Correspondence With The Scott For Florida Campaign. I am requesting copies of any and all correspondence to and/or from the emails with the domain “@rickscottforflorida” from October 10, 2018 through October 16, 2018.

Correspondence Mentioning Images And Video Of Hurricane Michael Recovery: I am requesting copies of any and all incoming and/or outgoing correspondence mentioning images and video of hurricane preparations, damage surveillance, and recovery efforts following Hurricane Michael from October 10, 2018 through October 16, 2018. This correspondence should include, but not be limited to, the distribution of the footage and images to the press as well as press inquiries regarding how the Scott for Florida campaign came into possession of the footage and images.

Detailed List Of Expenses Spent By The Executive Office Of The Governor In Filming Hurricane Michael Recovery Efforts. I am requesting a detailed list of expenses spent by Executive Office of the Governor to film and photograph Hurricane Michael recovery efforts in order to distribute footage and images to the press. The details of these expenses should cover from October 10, 2018 to October 16, 2018.

I realize that certain costs may be applicable to this request. Please contact me when you can provide a payment amount for my requests. In the meantime, I authorize an initial expense cap of \$500 to be accrued.

I also request that you state the specific legal and factual grounds for withholding any documents or portions of documents, should you withhold any. Please identify each document that falls within the scope of this request but is withheld from release.
