

JD MESNARD (LD 17)

As chair of the Senate Finance Committee, Senator Mesnard used his position to kill bills that would have capped the price of insulin, prevented insurance companies from issuing surprise bills, and stopped insurers from increasing the cost of diabetic supplies.

Over his long career in the Legislature, Mesnard has fought to keep local governments from requiring employers offer paid sick leave, supported imposing work requirements on Arizonans using the state's Medicaid program (Arizona Health Care Cost Containment System [AHCCCS]), voted to stop Arizona from restoring the state's children's health insurance program (KidsCare), and was the only senator to vote against setting up a maternal mental health advisory committee.

KATE BROPHY MCGEE (LD 28)

The current chair of the Senate Health and Human Services Committee, Senator Kate Brophy McGee sponsored a bill to expand access to junk insurance plans that could decide not to offer coverage for essential health benefits like hospitalizations and maternity care. She's also voted against allowing patients to challenge large surprise medical bills, supported ending public funding of women's health clinics that offer cancer screenings, and voted to remove the requirement that foster parents vaccinate their children.

ANTHONY KERN (LD 20)

Representative Kern has used his position as chair of the House Rules committee to kill bills that would have provided dental care to pregnant women enrolled in the state's Medicaid program (Arizona Health Care Cost Containment System [AHCCCS]), and increased access to primary care providers for the Navajo Nation before the COVID-19 pandemic.

Rep. Kern has supported increasing the number of vaccine exemptions and voted to require doctors to overemphasize vaccine risks before giving them. He also opposed the restoration of Arizona's children's health insurance program, KidsCare, and voted to prevent Arizonans from being able to challenge surprise medical bills.

RICK GRAY (LD 21)

Senator Gray has spent his long career in the Legislature working to limit access to health care, including kicking up to 280,000 Arizonans off the state's Medicaid program (Arizona Health Care Cost Containment System [AHCCCS]), opposing the restoration of the state's children's health insurance program (KidsCare), voting to end public funding of women's health clinics that provide cancer screenings for thousands of Arizonans, and pushing an anti-vaccination agenda.
