

## MATT SHAHEEN (HD-66)

Representative Shaheen has spent his time in the House opposing affordable access to women's health care, such as providing diagnostic mammograms. Shaheen has repeatedly voted to allow insurance companies to dictate what medications patients could use. He also voted against Medicaid expansion, which would have given over 1 million Texans access to health care; during the COVID-19 pandemic.

## JEFF LEACH (HD-67)

Representative Leach has used his position in the House to push a dangerous anti-vaccination agenda, including sponsoring an amendment allowing personal exemptions for vaccines. He voted against expanding Medicaid to cover more than one million more Texans; and introduced an amendment to stop the Governor from being able to expand Medicaid. Leach also supported allowing insurance companies to make medical decisions instead of doctors and patients.

Meyer also voted to block an increase in nursing home funding, which would have given homes the ability to hire and retain trained staff.

## ANGIE CHEN BUTTON (HD-112)

Representative Angie Chen Button voted twice to stop Medicaid expansion, which would have given over one million Texans access to health care. She also voted to block an increase in nursing home funding, which would have given homes the ability to hire and retain trained staff, including one home in her district that had a below average staffing level, leaving it vulnerable during the COVID-19 pandemic.
