CARSON WAS A HARDLINE ANTI-ABORTION ACTIVIST WHO COMPARED ABORTIONS TO "HUMAN SACRIFICE" AND SUPPORTED OVERTURNING ROE V. WADE

Highlights:

- Ben Carson was an anti-abortion hardliner who compared the practice to "murder" and "human sacrifice."
 - Carson has compared abortions to human sacrifices in ancient civilizations, implying a moral equivalence: "we sit around and call other ancient civilizations 'heathen' because of human sacrifice, but aren't we actually guilty of the same thing?"

- Ben Carson called for the overturning of Roe v. Wade and has pledged to aid in post-Roe anti-abortion policymaking.
 - In January 2022, during the build up to the Dobbs decision, Carson joined an op-ed alongside a variety of anti-abortion groups, calling for Roe to be fully overturned. The op-ed specified that a ruling in favor of Dobbs, without a full overturning of Roe, would constitute an "unmitigated failure."
 - In the same op-ed, Carson pledged that his American Cornerstone Institute group, among other groups signed onto the op-ed, would aid in future anti-abortion policymaking in a post-Roe world. This included a pledge of support for crisis pregnancy centers and supporting anti-abortion protesters at abortion clinics.
 - In his 2023 endorsement of Donald Trump, Carson praised Trump for delivering "the greatest victory for pro-life Americans in 50 years" by appointing Supreme Court justices who overturned Roe.
- Ben Carson denied anti-abortion measures constituted a war on women's rights and called for women to be re-educated on the issue.
 - o Carson said women needed to be re-educated on abortion to align with his views.
 - o Carson said talk of abortion rights made women "get all riled up."
- Ben Carson has implied abortion was the biggest issue in Black America and used it to deflect from other concerns.
 - At the 2020 Republican National Convention, Carson defended Trump from claims of racism by citing Trump's anti-abortion record.
 - In 2015, Carson responded to a question on police reform and Black Lives Matter by arguing "the number one cause of loss of life in the Black community in America" was abortion, and that should take focus.
- While serving in the unrelated position of Secretary of Housing and Urban Development (HUD) under Donald Trump, Ben Carson got into a spat with Rep. Ilhan Omar (D-MN) in which he attacked her support for abortion rights.
- Ben Carson said he was "fully behind" defunding of Planned Parenthood, including endorsing the possibility of a government shutdown over the issue.
 - In 2015, Carson cited discredited videos when he supported efforts to defund Planned Parenthood, including an openness to forcing a government shutdown over the issue.
- Ben Carson supported the 2014 Hobby Lobby decision, which allowed employers to avoid covering contraception via religious objections.
- In 1992, Ben Carson publicly opposed a Maryland abortion rights referendum in a television advertisement.
 - Carson would later distance himself from the advertisement following claims of inaccuracies, saying he only did the ad as a friend had asked.

1992: Carson Appeared In An Ad Opposing A Maryland Abortion-Rights Referendum. According to the Washington Post, "With a month left until voters decide the issue, the campaign surrounding Maryland's abortion-rights refer-endum deteriorated last week into a confusing barrage of charges and countercharges that left many voters wondering what they are being asked to judge. Little wonder. Even one of the prime narrators in a television ad placed by opponents of the ballot measure, Question 6, could not seem to make up his mind. Benjamin Carson, a pediatric neurosurgeon at Johns Hopkins Hospital and a star of a commercial spon-sored by the Vote kNOw Coalition, asked that the ad be pulled off the air and said some information in it 'needs explanation to attain accuracy." [Washington Post, 10/4/92]

Carson Later Distanced Himself From Appearing In The Anti-Abortion Ad Following Criticism Of The Accuracy Of Its Claims, With Carson Saying He Only Did The Ad As A Friend Asked. According to the Washington Post,

"Benjamin Carson, a pediatric neurosurgeon at Johns Hopkins Hospital and a star of a commercial spon-sored by the Vote kNOw Coalition, asked that the ad be pulled off the air and said some information in it 'needs explanation to attain accuracy.' The ad had finished its run on Tuesday anyway, and sponsors said they stood by its claims: that the new abortion law has no health and safety regulations for abortion clinics, that it would allow profit-making abor-tion referrals and would not require parental notification before minors have abortions. Carson, who narrated the ad, issued a statement Thursday questioning the validity of the ad's claims on referrals and regulation of clinics. 'I was asked by a friend to appear in the advertisement and did not realize the full political implications of that action,' he said." [Washington Post, 10/4/92]
