**2022: Cameron: "I Support Donald Trump" In The Republican Primary.** According to the Louisville Courier-Journal, "Attorney General Daniel Cameron, the only Republican in a crowded 2023 primary for governor who has the endorsement of former President Donald Trump, returned the favor Tuesday when he told reporters he supports the ex-president's 2024 campaign to return to the White House. His endorsement came a couple of weeks after the U.S. House of Representatives committee that investigated the Jan. 6, 2021 attack on the U.S. Capitol recommended the Justice Department bring criminal charges against Trump for his actions related to that insurrection. Yes, I support Donald Trump in the (Republican) primary," Cameron said, though he noted GOP voters across the country will determine who their party's eventual nominee for president that year will be and made it clear he'll support whoever that nominee is."
